## **CIRCULAR**

Applications are invited from eligible candidates for filing-up of one post of Section Officer (Accts) and to create a panel for one post of Assistant (Accts), which are likely to be vacant soon, to be filled up on deputation/ re-employment basis in Mahanadi Water Disputes Tribunal, from the employees/officers from Central Government/U.T./State Governments/P.S.U, on terms and conditions of deputation, as contained in DoPT OM No.2/29/91-Estt. (Pay II), dated 17<sup>th</sup> June, 2010(as amended from time to time) and in respect of re-employment, employees/officers retired from Central Government/U.T./State Governments/P.S.U on terms and conditions of re-employment issued vide DoPT O.M. No. 3/03/2016-Estt.(Pay II) dated 01.05.2017 (as amended from time to time):

A. Section Officer(SO) On deputation basis: A Graduate from recognized University or equivalent, holding analogous post on regular basis, or holding post in Level-6 of the 7<sup>th</sup> CPC Pay Matrix, with at least 6 years regular service in the grade. Preference shall be given to candidate having experience in administration, or Cash and Accounts and having good knowledge in computer. (person having good working experience on PFMS, ebill, GeM are desirable for the post).

[Note; period of deputation/contract including the period of deputation/contract in another excadre post held immediately preceding the appointment in the same or some other Organization/department of the Central Government shall ordinarily not exceed 3 years or till the life of the Tribunal or till further orders whichever is the earliest. The maximum age limit for appointment by deputation shall not exceed 56 years.

**Re-employment:** Officers retired from the Central Government State Government /UT/PSU/Autonomous bodies/Semi Govt./Statutory Organization etc, having a degree from recognized University or equivalent, holding analogous post on regular basis, or Holding post in Level 6 or the 7<sup>th</sup> CPC Pay Matrix, with at least 6 years regular service in the grade.

Preference shall be given to candidate having experience in administration, or Cash and Accounts and having good knowledge in computer.(person having good working experience on PFMS, Ebills, GeM are desirable for the post),

Note: Provided that the initial appointment shall be for one year, which is likely to be extended on year to year basis, till he attains the age of 65 years. Beyond that the term of incumbent can be extended further for a period of not more than six months on the same terms and conditions in public interest, if required.

Failing which: On direct recruitment on contract basis as per Recruitment Rules.

- \*\* Person applying for the post should have knowledge in working on computer (word, excel, power point etc.), knowledge in Legal affair (desirable).
- **B.** Assistant(Accts) On deputation basis: A Graduate from recognized University or equivalent, holding analogous post on regular basis, or Holding post in Level-5 of the 7<sup>th</sup> CPC Pay Matrix with at least 6 years regular service, or Holding post in Level 4 of the 7<sup>th</sup> CPC Pay Matrix with at least 10 Years regular service in the grade. Preference shall be given to candidate having experience in Cash and Accounts and having good knowledge in computer.

[Note; period of deputation/contract including the period of deputation/contract in another excadre post held immediately preceding the appointment in the same or some other Organization/department of the Central Government shall ordinarily not exceed 3 years or till the life of the Tribunal or till further orders whichever is the earliest. The maximum age limit for appointment by deputation shall not exceed 56 years.

**Re-employment:-** Officer retired from the Central Government/State Government /UT/PSU/Autonomous bodies/Semi Government/Statutory Organization etc, having a degree from recognized University or equivalent, holding analogous post on regular basis, or holding post in Level 5 or the 7<sup>th</sup> CPC Pay Matrix with at least 6 years regular service, or holding post in Level 4 of the 7<sup>th</sup> CPC Pay Matrix with at least 10 Years regular service in the grade. Preference shall be given to candidate having experience in administration, or Cash and Accounts and having good knowledge in computer. ( person having good working experience on PFMS, ebill, GeM are desirable for the post).

Note: Provided that the initial appointment shall be for one year, which is likely to be extended on year to year basis, till he attains the age of 65 years. Beyond that the term of incumbent can be extended further for a period of not more than six months on the same terms and conditions in public interest, if required.

Failing which: On direct recruitment on contract basis as per Recruitment Rules.

\*\* Person applying for the post should have knowledge in working on computer (word, excel, power point etc.), knowledge in Legal affair (desirable).

The applicants should clearly indicate (as per Annexure form) in their bio data, name, father's name, date of birth, date of superannuation( if taken VRS, then attach last office certificate), present designation with pay scale, post held on regular basis with date and pay scale, name of the superannuation department with address, email & telephone number, service/experience in chronological order, educational/technical/special qualification, training if any undergone and any other information relevant to the post, with the declaration of completeness and correctness of application and declaration that he will not be allowed to withdraw his candidature once selected for the post.

The person selected for appointment will not be eligible for Government accommodation during the period of deputation / re-employment in this Tribunal.

The respective office/department while forwarding the applications of the candidate(s) for deputation should clearly certify the particulars along with CR dossiers for preceding 5 years and enclose the list of major/minor penalties imposed (if any) together with Vigilance/Disciplinary clearance.
